

# Girl Scout Alum Facts\*

#### The Girl Scout alum community is over 50 million strong.

Based on current U.S. government population estimates, there are approximately 143 million adult women in the United States.

More than 1 in 3 women in the United States were Girl Scouts at some point in their lives.



79% say they stand up for their beliefs and values

Compared to other women, Girl Scout alums embody higher levels of:

- **Courage**—*they show resilience* when learning from failure and *setbacks, take on challenges, are* ambitious, and aren't afraid to take risks (46% compared to 36%).
- <u>Confidence</u>—they accomplish what they set out to do and are assured in their abilities (66% compared to 53%).
- <u>Character</u>—they lead purposeful and meaningful lives, are honest and trustworthy, stand up for their beliefs and values, and actively contribute to others' well-being (74% *compared to 62% showed positive* values and 61% compared to 48% showed positive self-image).
